### **VOCA Grant Funding**

As you may have heard, the cap for Victims of Crime Act (VOCA) grant funding for the 2024-25 fiscal year is projected to be reduced to \$1.2 billion, down from \$1.9 billion in the 2023-24 fiscal year.

As a result, Victim Assistance grants, which are distributed by the Office of Emergency Services in California, are also expected to be reduced.



These grants are distributed to local victim services organizations such as domestic violence shelters and rape crisis centers. Advocates are urging the Legislature to include a General Fund backfill in the budget in the range of \$200 million in order to make up for this funding shortfall.

Victim Compensation grants, which help fund CalVCB, are not currently affected by this funding reduction. Compensation grants are awarded to states using a set formula of 75 percent of certified victim payments made from state funds. This distribution will not be changed by the lowering of the overall funding cap.

The VOCA Fix Act of 2021 was intended to reverse the decline in the balance of the Crime Victims Fund, but it is too early to assess the long-term impact of the legislation. We will continue to closely monitor the status of the Crime Victims Fund and any changes in VOCA grant funding.

### **Federal VOCA Regulations**

On February 5, 2024, the Office of Victims of Crime (OVC) proposed changes to VOCA Victim Compensation Program Guidelines. The guidelines had not been amended since they were established in 2001. The full public notice can be read here:

CalVCB is reviewing the proposed changes for potential impact on our program. Public comments on the regulatory changes can be submitted to OVC through April 5, 2024.



In 2024, the CalVCB executive team is taking the important step of developing a four-year strategic plan that will guide the organization from 2025 through 2028. Soon we will be reaching out to our local government and community partners to complete a short survey that will help the executive team determine which goals to prioritize in the strategic plan.

#### Did You Know?

In accordance with Government Code section 13953, an application for compensation shall be filed within seven years of the date of the crime, seven years after the victim attains 21 years of age, or seven years of the time the victim or derivative victim knew, or in the exercise of ordinary diligence could have discovered, that an injury or death had been sustained as a direct result of the crime, whichever is later.



CalVCB has discretion to accept a late application whenever good cause exists. Good cause for accepting a late application exists when circumstances hindered the victim from filing an application within the statutory filing period.

CalVCB may consider the following reason as good cause:

- 1. Whether the victim or derivative victim incurs emotional harm or a pecuniary loss while testifying during the prosecution or in the punishment of the person accused or convicted of the crime.
- 2. Whether the victim or derivative victim incurs emotional harm or a pecuniary loss when the person convicted of the crime is scheduled for a parole hearing or released from incarceration.

Other factors CalVCB may consider, but are not limited to:

- Physical, emotional, psychological or developmental condition (e.g. victim's age, cultural or linguistic barriers, disabilities, PTSD, etc.)
- Interpersonal crimes with unique dynamics and trauma (e.g. sexual assault, domestic violence, human trafficking, child abuse or serious bodily injury)
- New loss occurred The application is filed when the applicant discovers that he/she has incurred a pecuniary loss as a direct result of the crime (e.g., the victim did not file an application because he/she had no expenses when the crime occurred, but he/she now has bills that need to be paid.)
- Delayed reporting of the qualifying crime to law enforcement or other reporting

agency is reasonably excused when one of the following factors exists:

The claimant's age

 Documented physical or mental disability during the time period specified for filing an application and applicant did not have a conservator

Cultural or linguistic barriers

 Emotional harm or a pecuniary loss incurred by the victim or derivative victim while preparing to testify

• Emotional harm or a pecuniary loss incurred by the victim or derivative victim during the apprehension, prosecution or punishment of the offender(s)
